 - ii. Applications from willing Assignee / Encroachers in **Form-3**, for the lands specified in **schedule-2** expressing consent to participate in the land pooling scheme, in accordance with the provisions of the Act, and the broad objectives, process of the scheme, role and responsibility of Authority / Government / Assignee / Enjoyer, other salient features and terms and conditions for the land pooling scheme at schedule 3. The application shall reach the Competent Authority within fifteen (30) days from the date of publication of this notification in the village.
2. A copy of the plan of proposed area for the land pooling scheme is kept open for inspection of the interested parties / Assignee / Enjoyer including the public at the office of the Competent Authority for Land Pooling scheme during office hours and also in the website of the Authority.
3. The Competent Authority will conduct stakeholder consultations in the villages as given below in order to explain the details of the scheme.


